## **RELOCATION BENEFIT**

If you have relocated for work purposes you may be eligible for additional tax savings - over and above your ordinary salary packaging amounts - by salary packaging some or all of your relocation costs.

### What relocation costs can be packaged?

The following relocation costs can be salary packaged provided you meet the eligibility requirements:



Removal, temporary storage, shipping and insurance of household items



**Transport costs** (including airfares), meals and accommodation (for you and your family) that relate directly to the relocation



**Temporary** accommodation at the new or old work location



Connection of utilities at new location



Costs involved with the sale and/ or purchase\* of a residence-including stamp duty, legal fees and agent commission

\*note that purchase costs may only be claimed if you have sold a home in the former location.

Please note that you are unable to salary package a relocation cost if it's already been reimbursed to you by your employer, or will be reimbursed in the future.

#### How do I qualify?

You must be able to prove you have relocated from another town as a result of accepting employment, or a new employment roles, with your Local Health Agency.

This salary packaging opportunity is in addition to your annual salary packaging capped limit of \$9,009 and, unlike your capped benefits, relocation expenses are not included as a reportable fringe benefit amount on your end-of-year ATO payment summary.

## How much more can I save by salary packaging \$5,000 in relocation expenses?
